#### Part 3: Narrative

I was born in Cincinnati, Ohio to two New Yorkers who moved to Cincinnati for my dad to pursue a career in Marketing. We are a typical white, middle class family that grew up in the evangelical church tradition. My parents became Christians when I turned two, so my childhood was spent watching the development of their faith as they learned more about who Jesus was and, in turn, who Jesus said they were. They raised me and my two little sisters in the church, educating us as best they knew how to about what the practice of faith was and why they believed that Jesus had any specific claim over our lives. As we grew older, my father had different work opportunities around the States. As a result, I had the experience of moving every few years growing up. My itinerant childhood resulted in the church becoming my social foundation and my first community I loved as my own.

I stumbled into ministry as a senior in high school through the middle school ministry at my church. I fell in love with hanging out with my sixth-grade guys. We would play games, laugh a ton, and then talk about the Bible and Jesus. Through teaching them, I discovered a growing desire to know more about Jesus and where he fit into my life.

When I entered college, I joined a fraternity and became enamored with Greek life. I tried seeking acceptance through what my pastor called "garden variety fraternal hedonism". Yet, I never found the identity and acceptance in my fraternity as I did under the umbrella of Jesus' love and the church. A fraternity brother of mine invited me to a local church small group, and I again found the sense of identity within the lifestyle and identification as a Christian. The rest of my time in college was spent doing similar ministry as had been done to me. I loved working in ministry and, because I began taking my faith seriously during this time and leaning into the challenges of living life with Christ in a world that did not, I saw incredible growth in myself across this time.

As I neared graduation and reflected upon my time in college, my neuroscience degree and plans to pursue a career as a doctor began to feel fake and shallow. I reached the startling realization that I felt God's calling into ministry full time, not just for a summer. I applied for a year-long college ministry internship at University Presbyterian Church in Seattle, WA and did a year of full time vocational ministry before seminary. Within three weeks working there, I felt like the Lord was confirming my sense of calling into ministry.

After two years of seminary, I applied for a fully funded year long International Field Education placement in Groomsport, Northern Ireland. This year was pivotal in my understanding of pastoral ministry and personal development. I dove deeply into full time pastoral work, learned how to counsel and walk with a congregation, discipled young men in the church, and generally learned the daily rhythms of ministry.

After seminary, the Lord led me to Renaissance Church to work as the Pastor of Student Ministries. The two years spent on staff there were challenging. I was working in a culture foreign to me, ministering to students with needs that are real and deep, and the church culture was much different to what I had grown up with. I found myself stretched as a minister there. God humbled me, strengthened me, and forced me to grow in both grace and grit through my time there. And now I am back in CA!

My life has shaped my character very disctinctly. I deeply desire intentional

a. My leadership style: (How you include others in decision-making, administrative style, ways you deal with conflict, etc.?)

I tend to be a verbal processor, and I view others as very helpful in helping me make decisions. They are foils that allow me to talk out the different situations, and I am diligent in seeking others advice, but ultimately I will make a decision based upon what I think, feel, and pray to be true or faithful. I also tend to be decisive when I make a decision, moving foward as soon as the situation allows and I feel confident. I am not a natural administrator, and I have systems in place to help me manage this deficiency.

I am naturally a person who strives for harmony, but if something needs to be said, I will say it. I value dialogue deeply, and I desire to hear and understand another's point of view while being given the same opportunity. That said, I can be quite blunt when I need to, and I am a firm believer that honesty is better than platitudes. I think the church should be a place where we should be the most honest and most open to feedback, because our worth is not ultimately in our work, but in the Cross. But, it should always be offered in grace, not anger or frustration.

Because of my desire for conversation and clarity, I try to address conflict when I am able. It is definitely a growing edge of mine. But, I would rather talk about it than hide away from things.

#### b. My worship emphases: (preaching style, preferred worship emphases and style, etc.)

I am an exegetical preacher who loves going through a text with the people and expand what we find, but I think exegetical preaching falls flat without a strong emphasis upon the practical. My notes are broken down into intro, "what does the text say?", and "what now?" A sermon should encourage people forward to live lives rooted in the gospel and live out the gospel during the week. If they are not hungry for Jesus on Wednesday, worship that I led didn't do its job.

I have experience in traditional worship settings, but I am drawn to a modern style. I actually quite enjoy a traditional service now, but there is something in modern worship music that allows me to connect in worship with the Lord in a powerful way. A modern service with some semblance of a liturgical structure that emphasizes scripture, the proclamation of the Word, prayer, and perhaps a hymn or two is what I would ideally love.

Perhaps uniquely, I view pastoral care as a time of worship for me. Each interaction with someone in crisis, challenge, or transition seems to include an invitation from God to "take off your shoes, for this is holy ground." I worship through service.

c. My call to ministry: (What type of ministry role are you called to? What would effectiveness look like in that role?)

I feel drawn towards pastoral ministry with regular preaching and teaching, as well as regular interaction with the congregation through counseling, discipling, and bible studies. I have found that I am most directly drawn toward pastoral counseling, pastoral care, and preaching. I love to minister to the soul of those who I am caring for with the Word. And I deeply value being with people in their crises to be a minister of presence.

Effectiveness is measured as the intersection point of faithfulness to what God has called me to and diligence to work hard at those things. Am I doing my work well? Are people responding? Is my preaching well researched, revised, and practiced? Am I sabbathing well? Is my family my priority? Am I taking time to listen to God? Am I responding to God working in my prayer life? If I can answer yes to these quesitons, I would feel that I am being effective. My main goal is to be faithful to what God has placed in front of me to deal with today. Some days that is strategic planning, other days that is the people, and some days that is taking the time to rest. Effectiveness is something that is not easily defined or measured, but it is loosely summed up by the adjective "faithful".

Specifically regarding pastoral care, effectiveness looks like "holy listening" and compassionate communication. Holy listening involves listening for where a person REALLY is, and seeking to acknowledge that while pointing them toward the Lord. Compassionate communication seeks to speak to where a person is, not where they want to be with grace and truth.

#### a. Spiritual giftedness

We each were designed by the Lord to be an individual, with our own things to offer to the world. (Psalm 139). Paul makes it quite clear in his writing that he believes there are different roles for those in the church. It is a body, comprised of many parts (1 Cor 12). b. Charismatic expression in worship (manifestation of spiritual gifts)

I have long acknowledged myself jokingly as a "presbycostal", someone who is within the Reformed tradition, but deeply impacted by the ministry of the Holy Spirit. I believe that some are gifted with the expression of the Holy Spirit in incredible ways. Some are gifted with words of prophecy, of revelation. Paul testifies to this, encourages it, and offers advice how to guard against abuse of this gift in 1 Cor 14. Other gifts are seen throughout the scriptures as well.

We need to rediscover a reliance upon listening and praying for words of wisdom from God. Additionally, God gives us ways to relate to him in ways we cannot understand. I believe in tongues as an expression of intimacy, though I am uncomfortable with their expression in worship services because of the uncertainty regarding their interpretation. Again, 1 Cor 14 advises us, and we must be diligent to not slip into thinking that the Holy Spirit is something we control, but is an equal person of the Trinity with the Father and Son.

#### c. Women in ordained office

I am a firm believer in the ordination of women to the office of elder in the church, whether that is as a teaching or as a ruling elder. I think that the common biblical texts used to support a strict complementarian view of women in ministry (most notably 1 Corinthians 14:34-36, 1 Timothy 2:11-15, and Ephesians 5) are misconstrued and read out of context to support a traditional patriarchal expression of church life. Instead, I hold firmly that God co-equally expressed the Imago Dei through men and women, and that God has not distinguished between women and men in giving the Holy Spirit to us. #### 1. The Bible (Bibliology)

God has revealed himself to humanity throughout the ages, and God continues to speak to us today through the Holy Sprit's inspiration of Scripture (2 Tim 2:15-17). All of the Old and New Testament books are divinely inspired by God through the Holy Sprit (1 Pet 1:19-21). They are called Testaments because they testify to the work of God for humanity, which is seen in Jesus Christ, the word of God from beyond all time. The Word is still alive and active, and it continues to enable believers to discern God's voice. (Heb. 4:15). Scriptures are to be examined, interpreted, and studied in their original context and purpose within the larger narrative of salvation testified to in the larger story of the Bible.

#### 2. God the Father (Theology proper)

God is (Ex 3:14). Before the entire world was created by him, God has existed from before all time, complete within his existence (Col 1:17). He created the world (Gen 1:1, Job 38:4-11) and as creator, God's providence reigns over all creation (Jer 10:11-3). As creator, God gives us life and purpose in him and through his story of redemption and reconciliation (Acts 17:28). God cannot be rivaled, equaled, or surpassed.

#### 3. Jesus Christ (Christology)

Jesus Christ is God incarnate. He came to the world to reconcile humanity to God from their bondage to, and the death effected by, sin. The Old Testament foretold Christ and points to Christ. The New Testament reveals, testifies to, and affirms Christ's fulfillment of God's promise, desire, and heart towards humanity. Jesus is fully human and fully God, uniquely united yet completely distinct. He is without sin. Jesus lived a perfect life, gave himself up on the cross for us in death, and then rose three days later from the grave in a display of his power over sin and death. Through his death on the cross, Jesus is the atonement for our sin, and the one from whom our righteousness and salvation comes from.



#### 4. The Holy Spirit (Pneumatology)

The Holy Spirit is the third person of the Godhead who was sent to us to teach us about God, fill us with the same power that raised Jesus from the grave, draws us to God, and dwell within us when we respond to Jesus in faith. The Holy Spirit helps us to live in the freedom from sin that Jesus won for us. The Holy Spirit directs us, convicts us, and gives us power to accomplish more than we could ever ask for or imagine. The Holy Spirit intercedes for us before God and the Holy Spirit gives gifts that strengthen our faith and allow us to experience the presence of God in convincing and powerful ways. The Holy Spirit enables us to understand Scripture, experience God's presence, and is responsible for the divine authorship and inspiration of Scripture.

#### 5. Mankind (Anthropology)

Mankind was designed and created to reflect God's image and to be involved with God in fellowship. Through the Fall, humans have lived in a state of Holy distance (or, unholy distance) from God. Atonement and intercession was needed to pay for our state of sin, which was God's reason for the temple sacrificial system and for Christ. Jesus paid our penalty and redeemed us so that we might access to the Koininia between the Father and the Son through the Presence of the Spirit with us. Now, we live in between Jesus' first and second coming.

#### 6. Sin (Hamartiology)

Sin is both inherited and chosen. Inherited from Adam, chosen by me. Sin is humanity's willful choice to turn away from God. The result of sin is humanity's separation from God and the good that God has in store for us. All have sinned and chosen to rebel against God, and the just penalty of this rebellion is that we should lose any relationship with God, and we had. But because of God's love and mercy, Jesus Christ became an atoning sacrifice for sin that won victory. Sin is therefore nullified on the cross, but because our world is still fallen, we experience the sting of sin even as we know the freedom of the cross. We live in the already, but not yet Kingdom.

#### 7. Salvation (Soteriology)

Humanity was created to live in relationship with God, yet we turned away from God's glory into sin. Humanity constantly battles the sin of pride, which is a desire to be God. Because of God's great love for humanity, God the Father sent God the Son Jesus into the world so that whomever believes in Him shall not perish but have eternal life. We can't earn this life, but we can only receive it as a gift from God through faith by confessing our sinfulness and need for the saving work of Jesus on the cross. The atonement of sin is only found in the life, death, and resurrection of Jesus. We cannot change or atone for our separation from God ourselves, nor can we change our position before God without his sacrifice.



#### 8. Satan

God's enemy. The Liar. The Accuser stands against all that God is for. Satan tempted Jesus in the desert after his baptism and was defeated by Jesus' refutation of his lies with scripture. Satan opposes all who are for God. But, we are protected by God through his promise in Ephesians 5 that we shall be able to withstand the Enemy's attacks by his strength alone.

#### 9. Angels and Demons

They are real spiritual beings with no corporeal form. Dallas Willard calls them "purely spiritual beings". Demons are oriented towards serving Satan, Angels are God's servants. They interact with our world and lives in ways that are sometimes known, but often pass understanding.

#### 10. The Church (Ecclesiology)

The Church is God's people. God is the head of His Church, and His son Jesus gave Himself for the Church, and the Holy Spirit was sent to the Church to teach and equip the church to do God's work. The Church is to regularly gather to devote themselves to fellowship, communion, study, and prayer so that the church might be equipped to follow God and live on mission to the world. Jesus commanded the Church to go and make disciples, to baptize people and invite them into the Kingdom of God. The Church's mission is to serve the marginalized, to serve one another, to provide for those both in and outside of the Church, and to joyfully encourage one another that God is

We are Spiritual beings— God has created us with souls, and this means that our spiritual life is real and it matters. Worship is an incredibly powerful action because it shapes our soul. When we worship God, we are conformed to the Image of Christ, but when we worship other things, we fall into idolatry and thus become less like Christ. So, our spiritual life matters. And, not only does it matter, it is something that Satan and his demons are trying to distract, destroy, and divert humans away from worshipping God alone! So, we need to beware and be on guard with God's armor on us so that we might withstand. Yet, our lives are held in God's hand, so we need not be afraid.



#### 12. Future Things (Eschatology)

Jesus will return one day to call sinners to account for their lives. The dead who believed in Him will be raised and humanity will be judged. Those elected by Jesus will live eternally with him in the new kingdom. Those who are not elected by God are subjected to the just punishment of God. If I am honest, I find myself struggling with God's eternal rejection of some in eternal conscious torment. However, I also know that I am limited, and my knowledge and capacity to understand God is small, so I willingly submit to the discernment of the church taught through the confessions of our church. And I look forward to the end of time when the new Kingdom will have no curses, death, mourning, or pain, and all of God's promises and plan for creation will be fulfilled, thus bringing him glory.

#### 13. Evangelism

Christians are called to share their faith. Christ taught that his disciples are to "go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you. And surely I am with you always, to the very end of the age."

15. State your view of the Scriptures and the place the Scriptures will have in your ministry. I believe that the scriptures are infallible. They never fail to do what God intends for them to do— testify, teach, and convict the people God created about his his story of salvation. They are useful for teaching, rebuking, correcting, and training up in righteousness. Calvin's comment on what constitutes a church resonates with me— a church is the place where "the sacraments are rightly administered and the Word is rightly preached."

I strive to give God's word its proper place and position in the life and ministry of the church— at the center of all that I do. It informs counsel, direction, and the ministry God has called me to.

#### 16. What distinctions of the Reformed faith appeal to you?

I love the reformed traditions emphasis on God's sovereignty and the clear sighted view of humanity's sinfulness. I hold the encouragement of Karl Barth closely: "Ecclesia semper reformanda est..." which is translated something like "a church [once] reformed, is always reforming." This must be always according to the Word of God, never culture. If we as leaders fail to reconsider our own theological commitments in light of what God reveals in his Word to us, how can we ever ask those who are under our spiritual care to follow us? In this spirit, I firmly am committed to listening for God's voice amidst my thoughts and intellectual leanings in order to faithfully respond to where He is calling me deeper and higher into His presence. At the end of the day, my thoughts are not God's thoughts, and I trust that God himself will bring all things to completion and perfection when He returns. I like that the Reformed faith emphasizes that.

#### 17. What/Who is the Holy Spirit and how important is His ministry?

The Holy Spirit is the third person of the Godhead who was sent to us to teach us about God, fill us with the same power that raised Jesus from the grave, and dwell within us when we respond to Jesus in faith. The Holy Spirit helps us to live in the freedom from sin that Jesus won for us through bringing us into the communion that is experienced between the Father and the Son. The Holy Spirit directs us, convicts us, and gives us power to accomplish more than we could ever ask for or imagine. The Holy Spirit intercedes for us before God and the Holy Spirit gives gifts that strengthen our faith and allow us to experience the presence of God in convincing and powerful ways. #### 18. What is your position on women in leadership roles in the church?

I am all for it! God created men and women to steward the earth, together. It is only after the fall that God instituted any sort of heirarchy. When Christ came and "broke down the dividing wall of hostility", the Holy Spirit returned both men and women back into the Father's presence and, by proxy, to their co-equal leadership roles. In colloquial terms, "there is no male holy spirit". Throughout Paul's letters, we see various women serving in leadership roles. That fact helps me hold tension with the examples we have from his pastoral epistles that are negative imperatives concerning women in leadership. I find it likely that he was addressing a specific concern instead of a blanket statement.

# 19. What do you see as the strengths and weaknesses of the Presbyterian form of government?

One of the great strengths of the Presbyterian form of government is the diversification of power in the body. No one person is able to dominate. In this way, it is remarkable to me how elevating this form of government can be. People are honored as unique vessels of the Holy Spirit, irrespective of their class, socio-economic status, or education levels. It seems that it holds space for God's spirit to move and be discerned by the multitudes. My appreciation is also my hesitation however, because God's Spirit seems to be a dynamic operator, and at times the way that decisions are made can seem onerous and too slow. I worry that the Spirit is perhaps not given its full space to operate in the dynamic way seen in scripture and less structured forms of ecclesial government.

#### 20. Explain your philosophy of ministry.

My philosophy of ministry is rooted around one word: shepherd. I believe that Jesus is the Good Shepherd, but Jesus has given us pastors his task to love and lead the church. In a way, we could think of ourselves as sheepdogs—we are to protect the chruch, love her, lead her where the master leads us, and follow the master! We go find the lost sheep, and we proclaim that God has never lost them, but has always found them! (Or, in canine parlance, "woof woof woof!!" ... Something like that.)

I strive to shepherd those God has given me in my flock, whether that is customers at the running store I worked at in seminary, my youth group as a youth pastor, my young adult community group, or elderly shut-ins in Northern Ireland. I seek to minister with my presence, and each interaction with someone for me seems to involve "taking off my shoes, for this is holy ground." I minister from the Shepherd's directions back toward the Shepherd. I am not the shepherd, merely his agent in the world.



- 21. Describe your approach to evangelism, both personally and as a pastor in a local church. I love evangelism! I believe that the truest things about each person is that God loves them and they will forever be restless without knowing God's love. This means that God is always seeking them. So, I try to partner with God in this way. Sometimes, it looks like stopping someone on the street with a random question "hey, are you looking for something? I felt like I was supposed to talk to you..." Other times, it looks like being a person of peace in times of turmoil. And sometimes it looks like offering to pray for someone when things are hard/. But, my approach is to always be watching for the people God has for me to minister and evangelize to. I am not perfect, but I do feel strongly that evangelism is incredibly important. And, evangelism is not just a one time conversation. Barth once said that "we do not go on and on in our faith, we begin again and again." I like that!
- 22. As you reflect on your life, explain your sense of call to ministry. I began sensing a call to ministry as a child, but misinterpreted it as a desire to become a doctor to care for people. Through college, I interned at my home church, Community Presbyterian Church in Danville, and began seeing that I felt called to minister to people's soul needs, not just bodily needs. And they confirmed this call—they invited me to become a candidate.

Yet, I was pretty afraid to commit to a life of ministry. It took a random phone call from a friend offering me a chance to apply for a ministry job of a life time post-gradution that confirmed my sense that I was called to ministry. Seminary followed and I loved my pastoral and practical theology classes. I came alive during pastoral work, and so I have continued to follow this path that God has so clearly led me down. Even when ministry

23. Elaborate on your convictions about personal accountability in your life and in the lives of Christians to whom you might minister.

Personal accountability is immensely important to me as a minister of Christ. We are not perfect people, but I believe that those who are pastors are held to a standard that befits the level of exposure that we have in our work. Therefore, I welcome hard conversations about my action. I pray for God to shape my character. I pray with my wife for our marraige, and I prioritize her over all else save my own walk with Jesus.

I am someone who prioritizes very clear boundaries within my ministry--sharing with my wife when I have had a one-on-one meeting with a woman, having open dialogues with male friends about online activity, and meeting monthly with my spiritual director. These don't prevent "moral failings", but they do ensure that my life has as many touch points with others in open dialogue in view of God's grace to allow me time to repent, confess, and believe in God's grace anew each day.

Input/Letter from the General Assembly Parliamentarian

September 8, 2022

Mark,

I'm unclear as to the intent of the overture. What practical opportunities will open if this overture were adopted?

Here's the reason for the Book of Worship clarifying the Confession. Westminster 29-3 sounds a bit cryptic in saying that the sacrament is to be served to all present but not to anyone not present. The intent of that statement is elaborated in 29-4 where the practice of private masses (and other exclusive individual communion) is condemned.

Since taking communion to the sick is not a private service or exclusive observance, the Book of Worship 3-G-2 clarifies that it is an acceptable practice with Session oversight. It is seen as an extension of the corporate worship service necessitated by illness, not by nobility or a desire for exclusive communion.

The addition of the word "ordinarily" to the confession is not necessary and brings unintended problems. It is a vague enough statement to allow for at-home communion for live streaming services, a practice which was authorized by the GA during COVID lockdown, but expired when churches re-opened.

The Presbytery may submit any Overture it deems helpful and appropriate, but I don't see it as getting much traction at GA because the Assembly has been historically resistant to amending the Confession.

This response is in no way intended to block the overture, but just to point out the obstacles such an overture is likely to face.




