15-3 Welcome

TE David Burke, Pastor of Fremont Presbyterian Church, welcomed the Presbytery and shared a brief update on the ministry of the church.

15-4 Introduction of Guests

Moderator Roberts welcomed all commissioners and guests, including RE Rosemary Lukens, GA Moderator. Personal introductions were given to those who were attending a Presbytery of the Pacific Southwest meeting for the first time.

15-5 Worship

Moderator Roberts led the Presbytery in a Call to Worship from Psalm 27. The Fremont Presbyterian Worship Team led the Presbytery in musical worship. The sermon was given by Eric Amundson, candidate for Transitional Pastor at New Hope Presbyterian Church, Kent, WA. He preached on John 10:22-30, a passage assigned to him by the Ministerial Committee.

15-6 Moderator's Time of Prayer

Moderator Roberts then led a time of prayer focused on 1 Thessalonians 4:13, 14, 18 and 1 Corinthians 15:54-58. The Presbytery's prayer was focused on the family of TE Garrett Brown from Fair Oaks Church, who had suddenly passed away just recently.

15-7 Stated Clerk's Report

Stated Clerk Eshoff reviewed the protocol for participation and voting for the meeting. He also noted attendance expectations and the voting guidelines for the Presbytery, those Teaching Elders that were absent without excuse at the previous Presbytery meeting held on January 21,

2022, a reminder about the importance of attendance at Presbytery meetings and Teaching Elder Annual Reports, as well as the 2022 Parity List, which was available for pickup.

15-8 Approval of the Docket

Stated Clerk Eshoff presented changes to the proposed docket and recommended the revised docket to the Presbytery for approval.

Motion was sustained to adopt the docket as modified.

15-9 Address from the General Assembly Moderator

GA Moderator, Rosemary Lukens addressed the Presbytery and shared her thoughts on Philippians 4:4-6 in light of the world we live in and the cultural context of the day. She reminded the Presbytery of the importance of dealing biblically with the anxiety in our world, and of participation in the Presbytery. She shared the state and mission of the denomination and the General Assembly leadership, and encouraged the Presbytery to pray for all of the above.

15-10 Interview with the GA Moderator

Stated Clerk Eshoff interviewed the Moderator Lukens, who shared about her family, her role in the denomination, and her assessment of the GA's Strategic Priorities. POPS Moderator Roberts prayed for Rosemary and the EPC.

15-11 Ministerial Committee Report

TE David Abdo, Chair of the Ministerial Committee, opened in prayer and acknowledged Eric Amundson, candidate for Transitional Pastor at New Hope Presbyterian Church, Kent, WA. Because he recently moved to Southern California, he was seeking to transfer his membership from the EPC Presbytery of the Alleghenies to the Presbytery of the Pacific Southwest, and be approved to work temporarily Outside the Bounds of the Presbytery in a Transitional Pastor role. He had been examined by the members of the Ministerial Committee and was recommended to the Presbytery for approval.

Eric's examination began with a sermon on a passage assigned by the Ministerial Committee. The Presbytery examined him on his views of theology and sacraments, his faith in Christ, his calling to the ministry and the nature of the office of a minister of the Word, polity, the Reformed tradition, the Bible, and his spiritual journey. Eric had one exception to the Westminster Standards.

Motion was sustained to arrest the examination.

TE Amundson was dismissed during the Presbytery discussion.

Letters from RE Ron Bengelink and Rob Saunders, Clerk of Session at New Hope Presbyterian Church were read in support of Eric.

Motion was sustained to approve the examination of TE Eric Amundson, including his exception to the Westminster Standards, and receive him into full membership in the EPC Presbytery of the Pacific Southwest.

Motion was sustained to approve the Outside the Bounds call of Eric Amundson as Transitional Pastor of New Hope Presbyterian Church, Kent, WA.

Eric was invited back into the main session and was greeted with a standing ovation.

15-12 Installation of TE Eric Amundson

The Presbytery installed Eric into the role of Transitional Pastor at New Hope Presbyterian Church, Kent WA at the request of RE Ron Bengelink, Moderator of the Presbytery of the Pacific Northwest. Moderator Roberts asked Eric the constitutional questions for transferring pastors from the Book of Government 13-4 and 13-2B. These all being answered in the affirmative, prayer was then given for the pastor by TE David Abdo. TE Abdo then gave TE Amundson a charge from John 21:15-19. Stated Clerk Eshoff declared that he was duly and properly installed, in accord with the Word of God and the EPC form of government.

15-13 Session Minutes Review Committee

RE Janet Goodman, Chair of the Session Review Committee, opened in prayer, reported on the reviews from the May 2022 meeting, and updated the Presbytery on how to improve the effectiveness of Session Minutes. She also communicated the need for additional members of her standing committee for the current year.

15-14 Treasurer's Report

RE Connie Badgley, Treasurer, opened in prayer and gave the financial report, which included the 2022 year-to-date POPS Financials and Askings Report. She focused on the importance of Per Member Askings for the Presbytery and the denomination, as well as the Presbytery's designated funds, including the Pastors Care and Support Fund, which was the recipient of the offering at the worship service in the evening.

15-15 Mission Committee Report

TE Dave Fenska and Mindy Fenska, EPC World Outreach Liaisons, and TE Sam Knottnerus opened in prayer and updated the Presbytery on the activities of the Mission Committee. They shared about the strategic opportunities that are available to POPS churches to support the outreach to the Pashtuns, the POPS E2025 sponsored people group. Moderator Roberts prayed for the work of the committee.

15-16 Pacific Women's Link

RE Rebecca Duvall opened in prayer and shared an update on the recent Pacific Women's Link meeting and the opportunity that ministry provides for women in the POPS churches to connect and be filled.

15-16 Ministry Update – First Presbyterian Church, Fresno, CA

TE Jeremy Vaccaro opened in prayer and shared an update on the history and ministry of First Presbyterian Church in Fresno, CA. He shared both the joys of ministry and the challenges he and the church have experienced recently, encouraged the pastors to be aware of the need for self-care and to take advantage of counseling resources. Moderator Roberts presented Jeremy with an honorary carabineer to signify the church's connection to the Presbytery and TE Erik Buhl prayed for Jeremy and the ministry of the church.

15-17 Care of Candidates Committee Report

Examination of Ryan Balbi

TE Jay Hull, Chair of the Care of Candidates Committee, opened in prayer and introduced Ryan Balbi, who was ready to come under the care of the Presbytery. Ryan was currently the Interim Teaching Pastor at Christ Community Church, Carmichael, CA and was under the care of the Session of the church, who recommended him to the Presbytery as a Candidate Under Care. The candidate briefly shared his spiritual journey, his sense of call, and why he had chosen the EPC. The Presbytery then examined him on his Christian experience and growth, his motive for seeking ordination in the EPC, and his call to the ministry.

Motion was sustained to arrest the examination.

The candidate was dismissed to a soundproof breakout room. TE Dustin DeVriend from Christ Community Church spoke on behalf of the Session in support of Ryan.

Motion was sustained to approve Ryan Balbi to come under care of the EPC

Presbytery of the Pacific Southwest and approve TE Bryan Yeo as advisor to Candidate

Balbi.

The candidate was invited back into the room and was greeted with a standing ovation. Moderator Roberts asked the candidate the constitutional questions, to which the candidate responded affirmatively, and declared that the candidate was added to the Candidate's Roll. RE

Bob Balzhiser from Christ Community Church prayed for the candidate and TE Greg Alderman gave the candidate a charge.

15-18 Ministerial Committee Report (continued)

Examination of TE Matt Young

TE Abdo opened in prayer and introduced Matt Young, who had been called as Assistant Pastor of Outreach at Covenant Presbyterian Church, Orange, CA. He was seeking to transfer his membership from the EPC Presbytery of the West to the Presbytery of the Pacific Southwest. His Terms of Call had been reviewed and approved by the Ministerial Committee. He had been examined by the members of the Ministerial Committee and was recommended to the Presbytery for approval.

Matt's examination began with a sermon on 1 Peter 2:9-11, a passage assigned by the Ministerial Committee. The Presbytery then examined him on his views of theology and sacraments, his faith in Christ, his calling to the ministry and the nature of the office of a minister of the Word, polity, the Reformed tradition, the Bible, and his spiritual journey, as well as his one exception to the Westminster Standards.

Motion was sustained to arrest the examination.

Matt was dismissed during the Presbytery discussion. RE Stephen Morris and TE Scott Larson from Covenant Presbyterian Church spoke on Matt's behalf.

Motion was sustained to approve the examination of Matt Young, including his exception to the Westminster Standards, and receive him into full membership in the EPC Presbytery of the Pacific Southwest.

Motion was sustained to approve the Administrative Commission of TE's Patrick King from Covenant Presbyterian Church, San Diego, CA and Ryan Teramoto from Wintersburg Presbyterian Church, Santa Ana, CA, and RE's Shawn Smith and Catherine Gudvangen from Covenant Presbyterian Church, Orange, CA and Bob Parrish and Rick Priebisius from Covenant Presbyterian Church, San Diego, CA to install Matt Young as Assistant Pastor of Outreach at Covenant Presbyterian Church, Orange, CA on November 13, 2022 at 5:30 pm for a term of one year.

Matt was invited back into the main session and was greeted with a standing ovation. TE Scott Larson prayed for Matt.

15-19 Church Health Report

TE Mike Griffin, POPS Church Health Coordinator, gave an update on the need for Church Health coaches in the various regions of the Presbytery and reminded the Presbytery of the resources that are available for churches through his position.

15-20 GA National Leadership Team Report

GA Stated Clerk, Dean Weaver, greeted the Presbytery and gave a report on the GA Strategic Priorities via video. TE Meagan Bergem prayed for Dean, the ministry of the General Assembly, and the EPC denomination.

15-21 Nominating Committee Report

RE Bill Myers, Nominating Committee Chair, introduced nominees for POPS Moderator and several POPS committee positions.

Motion was sustained to approve TE Lana Roberts as Moderator of the Presbytery of the Pacific Southwest for 2023.

Motion was sustained to approve RE Christine Deane from Moraga Valley
Presbyterian Church, Moraga, CA as Chair of the POPS Nominating Committee and
member of the POPS Council.

15-21 Ascending Overture from Covenant Presbyterian Church, Orange, CA

In May 2022, the Session of Covenant Presbyterian Church, Orange, CA presented an overture for endorsement by our Presbytery to potentially be forwarded to the 43rd General Assembly in June 2023. The overture was made available to the Presbytery at the May 2022 POPS meeting for reading only and was to be considered at this meeting. Input on the motion had been received from Bob Garment, EPC Chief Parliamentarian. Concern was expressed that the input from the parliamentarian needed some clarification.

Motion was sustained to postpone the action to endorse the Overture from Covenant Presbyterian Church, Orange CA regarding changing the wording in the Westminster Confession, Chapter 29 - The Lord's Supper to the January 2023 POPS Meeting.

15-22 Retirement Recognition – TE Heidi Johnson

Heidi Johnson was ordained as a teaching elder and installed as Associate Pastor for Care at Community Presbyterian Church, Danville, CA in November 2013. She was previously a member of Centerpoint Community Church in Roseville, CA, where the Session wholeheartedly recommended her for the Gospel ministry. Her gifts of leadership, compassion and care, coupled with her doctrinally sound, clear and practical counsel have been a blessing to all with whom she has ministered.

RE Callisa Larue shared about the impact of Heidi's ministry at CPC, Danville and Heidi shared briefly about the new season in her life. Stated Clerk Eshoff presented her with a gift of recognition for her many years serving Christ and His church and TE Ryan Suzuki prayed for her.

Motion was sustained to approve the change in status of TE Heidi Johnson from Associate Pastor for Care at Community Presbyterian Church, Danville, CA to Associate-Retired, effective September 1, 2022, with great appreciation for her service to the church and to the Presbytery.

15-23 Meeting Recess

The meeting was recessed until the following morning at 9:00 am. Dinner was served by the volunteers and staff of Fremont Presbyterian Church. Following the dinner, the Presbytery joined in worship led by TE David Burke and members of the Fremont Music Ministry. An offering was received for the Pastors' Care and Support Fund and Communion was served.

15-24 Call to Order and Opening Prayer

TE Lana Roberts, Moderator, reconvened the meeting at 9:05 am on Saturday, October 22, 2022, and opened in prayer.

15-25 Appreciations to the Host Church

Moderator Roberts expressed deep appreciation to the host church, Fremont Presbyterian Church, TE David Burke, TE Dave Pack, and all the volunteers for their hospitality and support.

15-26 Worship

Moderator Roberts led the Presbytery in a Call to Worship and the Fremont Presbyterian Worship Band led the Presbytery in musical worship. The sermon was given by Matthew McCleary, candidate for Assistant Pastor for Congregational Life at Fremont Presbyterian Church, Sacramento, CA. He preached on Luke 15:8-10, a passage assigned to him by the Ministerial Committee.

15-27 Moderator's Time of Prayer

Moderator Roberts then led a time of prayer around the tables focused on Psalm 25 and Psalm 108.

15-28 Ministerial Committee Report (continued) - Examination of Matthew McCleary

TE Abdo opened in prayer and acknowledged Matthew McCleary, who had been called as Assistant Pastor for Congregational Life at Fremont Presbyterian Church, Sacramento, CA and was seeking ordination in the EPC. He had signed his Ministerial Obligation Form and Ethical Affirmations Form and he will attend an upcoming Discovery Workshop. He had been examined by the members of the Ministerial Committee, and his Terms of Call had been reviewed and approved by the Committee. He was recommended to the Presbytery for approval.

Matthew's examination began with a sermon on a passage assigned by the Ministerial Committee. The Presbytery then examined him on his knowledge of theology and sacraments, his faith in Christ, his calling to the ministry and the nature of the office of a minister of the Word, polity, the Reformed tradition, the Bible, and his spiritual journey. He had no exceptions to the Westminster Standards.
