EPC Officer Examination Requirements

EPC Book of Order

12-6 The examination of a Candidate for Ruling Elder or Deacon

The Session shall confer with each person elected to office in the local church to determine if that person feels called to office and is willing to serve faithfully. The Session shall examine candidates for ordination to the office of Ruling Elder or Deacon on:

- 1. Personal experience of the saving grace of God in Jesus Christ and progress in spiritual growth
- 2. Theology and Sacraments of the Church,
- 3. The government of the Church
- 4. Discipline of the Church
- 5. Worship of the Church
- 6. History of the Church
- 7. An understanding of the office to which one is elected

12-7 The examination of a previously ordained Ruling Elder or Deacon

- A. Those previously ordained into the office to which one has been called shall be examined by the Session on views of those subjects set forth for ordination. Each shall also give testimony of the personal experience of the saving grace of God in Jesus Christ and progress in spiritual growth.
- B. Those ordained to corresponding offices in other Reformed denominations shall be examined by the Session as one being ordained. Upon successful examination, previous ordination shall be recognized. The act of ordination shall not be repeated.

Resources

Nominated officers receive a POPS Officer Training Manual. They also each receive a Study Plan for preparation for the examination (see below), as well as the EPC Leadership Training Guide, the Book of Order, and the Westminster Confession and Catechisms.

Session Member Role

A pair of Session members interviews nominees individually. If there aren't enough Session members, deacon nominees may be interviewed in small groups. Begin by discussing nominees' response to Question #1 (Faith story). Work through the Examination Questions #2-19 in a discussion/review format, using the Reference Guide in the Officer Training Manual. Those interviewing nominated elders should make sure they respond to each question. Once you have discussed the responses to those questions, make sure each person has a chance to respond to Questions #20-24. You will have approximately 60 minutes for this discussion, so manage your time with that in mind. When the time is complete, all participants will reconvene and close in prayer as a full group.

Preparation

The following are suggestions for preparation for the training sessions.

Officer Training Manual

This will be the guide for our teaching and discussion. The teaching will focus on "The Essentials of Our Faith" on page 3 and on the Questions and Reference Guide on pages 5-7. Although we won't be spending the time to work through the detailed information on pages 12-26, it provides a good vehicle to do more in-depth personal or group study of our beliefs and our system of government. As officers of the church, your knowledge in these areas is expected as you participate in leadership of the church and a more detailed review would enhance your understanding of the ministry context into which God has called you.

Leadership Training Guide

This is the guide provided by the EPC denomination to equip all the officers in each church. It has an excellent summary of both church history and theology. We

recommend that you read as much of it as possible prior to the training session. Of particular note are the following sections, which would be important to study:

Page 3 – 5 Ordination Vows and backup references on each of the vows Chapter 4 Theology

Chapter 6 Christology

Chapter 7 Soteriology (Salvation)
Chapter 12 Church Government

Book of Order

This is made up of the Book of Government, Book of Worship and Book of Discipline. We will use this as a reference for addressing the discussion and examination questions. The current Book of Order is available online, so we suggest that you download it on your computer or mobile device.

Westminster Confession and Catechisms

Read through the Shorter Catechism (beginning on page 113), which is a summary of all that is addressed in the full Confession. Note any responses for which you have questions or disagreements.

Additional Information

We intend for the training and examination to be cordial and educational. The training portion will be accomplished as a single group and the discussion/examination portion will consist of small groups of elder/deacon elects and one or two elders, who will work through, in a discussion format, a selection of questions from the list on pages 5-6 of the Officer Training Manual.
