21-3 Welcome

TE Tyler Scott, Pastor of Community Presbyterian Church, welcomed the Presbytery and shared a brief update on the ministry of the church.

21-4 Introduction of New Commissioners and Guests

Moderator Wyatt welcomed all commissioners and guests. Personal introductions were given to commissioners who were attending a Presbytery of the Pacific Southwest meeting for the first time.

21-5 Worship

Moderator Wyatt led the Presbytery in a Call to Worship from Psalm 145. The Worship Team from CPC led the Presbytery in musical worship. The sermon on 2 Corinthians 4:1-6 was given by Dr. Ron Pyle, Professor Emeritus of Communication at Whitworth University in Spokane, WA who spoke at the Pastors Retreat earlier in the week. Ron earned graduate degrees in Theology and Communication. He retired in 2021 after 34 years of teaching at Whitworth. Ron taught courses related to human relationships, theories of communication, social influence, preaching, and small group ministry. Ron leads retreats and seminars on topics including biblical approaches to healthy relationships, marriage and family relationships, effective preaching, and conflict management in the church.

21-6 Moderator's Time of Prayer

Moderator Wyatt then led a time of prayer focused on Matthew 7:24-29. Members, commissioners and guests prayed the scripture in small groups.

21-7 Stated Clerk's Report

Stated Clerk Eshoff reviewed the protocol for participation and voting for the meeting. He also noted attendance expectations, the voting guidelines for the Presbytery, and those Teaching Elders that were absent without excuse at the previous Presbytery Meeting held May 16-17, 2024. He noted the resources available from the General Assembly office, including updates on the Gospel Priorities and opportunities for various GA-sponsored retreats. He also reminded the Presbytery about opportunities to host future POPS meetings and requested prayer for Cathy Cole, Presbytery Assistant who was not present due to the death of her mother and for Moderator Wyatt's father who recently underwent heart surgery.

21-8 Approval of the Docket

Stated Clerk Eshoff presented changes to the proposed docket and recommended the revised docket to the Presbytery for approval.

Motion was sustained to adopt the docket as modified.

21-9 Mission Committee Report

TE Dave Fenska, Chair, opened in prayer and introduced World Outreach workers who were present at the meeting. TE Sam Knottnerus, chair of the E2025 Home Team introduced Dave Matthews who serves with Reflejo, a partner mission agency that has a burden to reach the Pashtuns, the POPS sponsored people group. RE Chris Rhodes from Covenant Presbyterian Church, Reno, NV, shared their recent positive experience of hosting a mission worker from Reflejo. TE Knottnerus reminded the Presbytery of the POPS Pashtun website and closed the report in prayer.

21-10 Church Planting Report

TE Shawn Robinson, POPS Church Planting Coordinator, introduced TE Troy Wilson who opened in prayer and shared an update on the Table Church in San Francisco, CA, which began as an EPC church plant. TE Robinson shared an update on a possible new POPS church plant and the process of identifying and assessing a church planter. He introduced TE Joe Mazella, who will be participating in a church planter assessment process to possibly serve in the new church plant. TE Marcos Ortega and TE Dave Constance from FPC Bakersfield spoke of their enthusiasm to support the effort. TE Robinson then encouraged the Presbytery to participate in providing initial donations to fund the assessment effort and introduced Tom Ricks, EPC National Director of Church Planting, who encouraged the Presbytery to join in the support. TE Rick closed the report in prayer.

21-11 Session Minutes Review Report

RE Janet Goodman, Chair of the Session Minutes Review Committee, opened in prayer and reported on the reviews from the May 2024 meeting and updated the Presbytery on how to improve the effectiveness of Session Minutes.

21-12 Ministry Update – Covenant Presbyterian Church, Reno, NV

TE Jay Hull shared an update on the ministry of Covenant Presbyterian Church, Reno, NV, including the joys and challenges of ministry and the recent workshop featuring Andrew Brunson, which was a rich experience for all who attended. TE Greg Flagg prayed for Jay and the church.

21-13 Special Panel Presentation – "Navigating a Divisive Election – Perspective and Care for Our Congregations"

Following lunch prepared by the CPC volunteers, the Presbytery engaged in a panel discussion to help leaders of churches provide encouragement, perspective, and a Christian filter for their people in processing the dynamics of the election, given the angst and concern that the election is creating. Featured on the panel were Dr. Joel Landis, Professor of Political Science at UC Santa Cruz, Dr. David Nystrom, Professor of New Testament at Western Seminary and former Provost and Sr. Vice President of Biola University, and Dr. David Burke, POPS Chaplain and Pastor to Pastors with Standing Stone Ministry. After brief presentations the panelists addressed questions posed by the presbytery attendees. Moderator Wyatt closed the presentation in prayer.

21-14 Treasurer's Report

RE David Sylvester, POPS Treasurer, opened in prayer and shared the POPS financial update for the month ended August 2024 (attached). He noted that Percentage of Income giving continued to lag behind expectations and was likely affected by the significant increased insurance expenses that many California churches are facing. He commented that a brief survey is being prepared to inquire of POPS churches what kind of assistance the Presbytery might provide in navigating financial challenges. RE Sylvester closed his report in prayer.

21-15 Ministerial Committee Report

TE David Abdo, Chair of the Ministerial Committee, opened in prayer and introduced Will Carreras.

Examination of Will Carreras

Will Carreras had been called as Assistant Pastor for Missions and Mercy Ministry by the Session of Covenant Presbyterian Church, San Diego, CA. He was seeking ordination in the EPC and had signed his Ministerial Obligation Form and Ethical Affirmation Form. He had been examined by the members of the Ministerial Committee and his current Terms of Call were reviewed and approved by the Committee. He was recommended to the Presbytery for approval.

Will's examination began with a sermon on Acts 4:8-12, a passage assigned by the Ministerial Committee. The Presbytery examined him on his knowledge of theology and sacraments, faith in Christ, calling to the ministry, the nature of the office of a minister of the Word, polity, the Reformed tradition, the Bible, and his spiritual journey. Will had no exceptions to the Westminster Standards.

Motion was sustained to arrest the examination.

Will was dismissed during the Presbytery discussion. TE Patrick King from Covenant Presbyterian Church, San Diego, CA spoke in support of Will.

Motion was sustained to approve the examination of Will Carreras and receive him into full membership in the EPC Presbytery of the Pacific Southwest.

Motion was sustained to approve the Administrative Commission of TE's David Fenska (Active-Retired) and Patrick King from Covenant Presbyterian Church, San Diego, CA and RE's Alicia Luschei, Rick Priebisus, Bo Harvey from Covenant Presbyterian Church, San Diego, CA and Stephen Morris from Covenant Presbyterian Church, Orange, CA to ordain and install Will Carreras as Assistant Pastor for Missions and Mercy Ministry at Covenant Presbyterian Church, San Diego, CA on November 10, 2024 at 12:00 pm for a term of 3 years. Will was invited back into the main session and was greeted with a standing ovation. TE Patrick King prayed for Will.

21-16 Dissolution of Call – TE Joe Mazzela

The congregation of Sanger Community Church and TE Joe Mazzela had agreed to dissolve their relationship effective August 31, 2024.

Motion was sustained to approve the dissolution of the relationship between TE Joe Mazzela and Sanger Community Church effective August 31, 2024, and change his status to Without Call.

TE David Burke prayed for Joe and the church.

21-17 Change in Status – TE Jeff Hooker

The congregation of Centerpoint Community Church, Roseville, CA had called TE Jeff Hooker to the position of Associate Pastor of Spiritual Formation. He was currently the Assistant Pastor of Spiritual Formation at the church. This change had been reviewed by the Ministerial Committee and was recommended to the Presbytery for approval.

Motion was sustained to approve the Change in Status of TE Jeff Hooker from Assistant Pastor of Spiritual Formation to Associate Pastor of Spiritual Formation at Centerpoint Community Church, Roseville, CA.

Motion was sustained to approve the Administrative Commission consisting of TE's Bryan Yeo and Rachel Dorsey from Centerpoint Community Church and RE's Sharon Wurst, Tim Kovar, Joe Watkins from Centerpoint Community Church and Vicki Meyer from Fremont Presbyterian Church, Sacramento, CA to install TE Jeff Hooker as Associate Pastor of Spiritual Formation at Centerpoint Community Church on October 20, 2024, at 11:35 am.

TE Matthew McCleary prayed for Jeff and the church.

21-18 Change of Call – TE Eric Amundson

TE Eric Amundson had completed his service as Transitional Pastor at Hope Church, Kent, WA and had been called to Hope Church, Carbondale, IL as Transitional Pastor. He had requested that POPS affirm his Outside the Bounds call. He will remain a member of POPS.

Motion was sustained to approve the call of TE Eric Amundson to work Outside the Bounds of the Pacific Southwest Presbytery at Hope Church, Carbondale, IL beginning September 22, 2024.

21-19 Transfer of Ordination – TE Greg Ehlert

TE Greg Ehlert was currently serving an Outside the Bounds call with Restoration Project in San Diego, CA. He had been called to Renew Community in San Diego, a Reformed Church of America congregation and had requested a transfer to the City Classis of the RCA.

Motion was sustained to approve the transfer of TE Greg Ehlert to the Reformed Church in America City Classis effective October 17, 2024, contingent on his acceptance by the Classis.

TE David Abdo prayed for both Eric and Greg in their new calls.

21-20 Nominating Committee Report

RE Christine Deane opened in prayer and introduced RE Chris Rhodes, a member of the Nominating Committee, who recommended nominees for several POPS committees and an officer.

Motion was sustained to approve the nomination of TE Jay Hull from Covenant <u>Presbyterian Church, Reno, NV as a member of the Nominating Committee – Class of</u> <u>2027.</u>

Motion was sustained to approve the nomination of TE Joe Tolin from Kingman Presbyterian Church, Kingman, AZ as a member of the Care of Candidates Committee – Class of 2027.

Motion was sustained to approve the nomination of TE Lana Roberts (Active-Retired) as a member of the Ministerial Committee – Class of 2027.

Motion was sustained to approve the second term of RE Brian Wyatt as POPS Moderator for 2025.

RE Deane closed her report in prayer.

21-21 Ministry Update – Christ Church East Bay

TE Jonathan St. Clair shared an update on the ministry of Christ Church East Bay, Berkeley, CA, including the joys and challenges of ministry and several prayer requests. TE Dave Ricketts prayed for Jonathan and the church.

21-22 Change in POPS Bylaws

Stated Clerk Eshoff presented the reasoning behind the recommendation of the POPS Council to change the POPS Bylaws to allow the Ministerial Committee Chair to serve unlimited terms.

Motion was sustained to modify the POPS Bylaws Section 6.04 to establish unlimited 3year terms for the Ministerial Committee Chair.

Motion was sustained to approve the nomination of TE David Abdo as Ministerial Committee Chair – for a three-year term through 2027.

21-23 Descending Overtures from the 44th General Assembly – First Reading

Stated Clerk Eshoff presented the two (2) descending overtures from the recent 44th General Assembly meeting in June. These overtures were provided for reading only in anticipation of a formal vote at the January 2025 POPS Meeting.

21-24 Meeting Recess and Dinner

The meeting was recessed until the following morning at 9:00 am. Dinner was served by the CPC volunteers.

21-25 Presbytery Worship Service

The POPS Worship Service was led by TE Cathy Burkholder and the staff and leaders from Community Presbyterian Church. Caleb Bonifay, a member of the staff at CPC, preached the sermon. Communion was served and an offering was received for the POPS Church Planting Fund.

21-26 Call to Order and Opening Prayer

Following a breakfast served by CPC volunteers, Moderator Wyatt called the meeting back to order at 9:05 am on Saturday, October 12, 2024, and opened in prayer.

21-27 Appreciation to the Volunteers and Staff of the Host Church

Moderator Wyatt expressed deep appreciation to Community Presbyterian Church, their pastors and staff, and the volunteers that served the Presbytery in hosting the meeting. The volunteers were given a standing ovation.

21-28 Worship

Moderator Wyatt led the Presbytery in a Call to Worship from Psalm 9:1-2. The Worship Team from CPC led the Presbytery in musical worship. The sermon on 1 Corinthians 2:1-5 was given by Ken Ferguson, Candidate for Pastor at San Ramon Presbyterian Church, San Ramon, CA.

21-29 Moderator's Time of Prayer

Moderator Wyatt then led a time of prayer focused on Matthew 10:26-33. Members, commissioners and guests prayed the scripture in small groups.

21-30 Ministerial Committee Report (continued)

TE Abdo opened in prayer and introduced TE Ken Ferguson, candidate for Pastor at San Ramon Presbyterian Church.

Examination of Ken Ferguson

Motion was sustained to approve the Administrative Commission of TE's Bill Haslim from Community Presbyterian Church, Danville, CA and Shawn Robinson from Clayton Community Church, and RE's Doug Fry, Steve Liao and Mike Goldsmith from San Ramon Presbyterian Church and Rhea Serpan from Community Presbyterian Church, Danville, CA to install Ken Ferguson as Pastor of San Ramon Presbyterian Church on November 3, 2024, at 7:00 pm.

Ken was invited back into the main session and was greeted with a standing ovation. TE Bill Haslim prayed for Ken and the church.

21-31 Church Health Report

TE Mike Griffin, POPS Church Health Coordinator, opened in prayer and reminded the Presbytery of the threefold priorities of the Church Health Team: Transitional Pastor training, evangelism workshops, and church revitalization processes, including mission vision and alignment. He led a brief time of one-on-one interaction and encouraged members of the Presbytery to share a strength, challenge, and opportunity they would identify for their church.

21-32 Ministry Update – TE Ryan Suzuki

TE Ryan Suzuki was serving in an Outside the Bounds call at 3Crosses Church is Castro Valley, CA. He updated the Presbytery on the joys and challenges of his ministry and shared ways that the Presbytery could pray for him. TE Cathy Burkholder prayed for Ryan.

21-33 Care of Candidates Report

TE Matt Young, Chair of the Care of Candidates Committee, opened in prayer and encouraged churches to identify potential candidates for ministry to consider ordained ministry.
