- Rev. Jeff Chandler welcomed the Presbytery and gave a brief overview of the history and ministry of First Presbyterian Church, Bakersfield, CA. Moderator Perkins presented to Jeff and his church the honorary POPS carabineer, which represents the connected community of the Presbytery of the Pacific Southwest, of which they are a part.
- 5-4 Moderator Perkins asked new commissioners and new observers to stand and thanked them for their participation.
- Marsha Skidmore from First Presbyterian Church, Bakersfield, CA led the Presbytery in worship. Rev. Jason Yum shared a sermon on Jeremiah 31:31-34 as part of his examination in preparation for transfer to the Presbytery from the Presbytery of the Pacific Northwest.
- Moderator Perkins asked the Presbytery to pray around their tables with a focus on Jeremiah 31, as well as offering prayers for TE Tony Winterowd's mother who was involved in an auto accident and for Cindy Jeremiah.

#### 5-7 Stated Clerk's Report

Stated Clerk Eshoff reviewed the attendance expectations and noted those teaching elders that were absent without excuse at the previous Presbytery meeting held on January 25-26, 2019. He also reviewed the voting guidelines for the Presbytery, noted the informational handouts that were available at the handout table, and emphasized the importance of the TE Annual Reports, which were distributed to all active members of the Presbytery at the beginning of February. He then asked TE Jay Hull to reflect on the priorities the Presbytery has set for POPS meetings: 1) worshipping together, 2) connecting with one another, 3) development and resourcing our churches, and 4) making decisions about significant changes for our brothers and sisters, as well as affirming and supporting one another. He noted that the Presbytery meetings are part of "being the church."

# 5-8 Approval of the Docket

Stated Clerk Eshoff presented changes to the proposed docket to the Presbytery for approval.

Motion was sustained to adopt the modified docket.

# 5-9 Nominating Committee Report

TE Dave Brogren, Chair of the Nominating Committee opened in prayer and presented a nomination for the Ministerial Committee – Class of 2021

Motion was sustained to approve the nomination of RE Chris Larsen from Fair Oaks

Presbyterian Church, Fair Oaks, CA as a member of the Ministerial Committee (Class of 2021).

TE Brogren then presented the nomination for the Care of Candidates Committee – Class of 2021.

Motion was sustained to approve the nomination of RE Stephen Morris from Covenant Presbyterian Church, Orange, CA as a member of the Care of Candidates Committee (Class of 2021).

TE Dave Ricketts prayed for the two nominees and for the work of the Ministerial and Care of Candidates Committees. TE Brogren shared the need for additional RE's to serve on the various Presbytery committees.

#### 5-10 Session Minutes Review Committee

RE Jim Conners, Chair of the Session Review Committee, opened in prayer and reviewed the process. He requested six commissioners (four ruling elders and two teaching elders) to assist in the minutes review. #### 5-11 Care of Candidates Committee Report

TE Jay Hull, Chair of the Care of Candidates Committee, opened in prayer and then shared that several candidates had requested removal as Candidates Under Care, and commented on the integrity of the candidates in making this decision.

Motion was sustained to remove David Kim and Kathleen Harrell as Candidates Under Care of the Presbytery.

TE Hull prayed a prayer of thanks for David and Kathleen.

TE Hull then introduced Jeremiah Ramer, who was ready to come under the care of the Presbytery. TE Hull prayed for him. Jeremiah was currently under care of the Session of Community Presbyterian Church, Danville, CA. The Session had recommended him to the Presbytery as a Candidate Under Care.

Jeremiah briefly shared his spiritual journey, his sense of call and why he has chosen the EPC. The Presbytery then examined him on his Christian experience and growth, his motive for seeking ordination and his call to the Ministry.

# Motion was sustained to end the examination

Following the examination, Jeremiah was dismissed from the room. RE Mike Miller spoke in support of Jeremiah's candidacy.

# Motion was sustained to approve Jeremiah Ramer to come under care of the EPC Presbytery of the Pacific Southwest and approve TE Bill Haslim as advisor to Candidate Ramer.

The candidate was invited back to the room and received a standing ovation.

The following Constitutional Questions were asked of and answered in the affirmative by the Candidate:

- As you understand God's working in your heart and life, do you continue to believe yourself called to the office of Teaching Elder?
- Do you now submit yourself to the care and supervision of this Presbytery as you prepare yourself for this office?
- Do you renew your commitment as a Christian, in humble reliance upon the grace of the Holy Spirit, to live as becomes a follower of Jesus?

Moderator Perkins invited members of the Presbytery to come forward to pray for Jeremiah. RE Rhea Serpan led in prayer. TE Heidi Johnson gave a charge to Jeremiah from Ephesians 3:7-8.

# 5-13 Protecting our Churches

Stated Clerk Eshoff presented the updated policy on Harassment, which was sent back for revision at the January 2019 meeting.

Motion was sustained to approve the Harassment Policy for the EPC Presbytery of the Pacific Southwest.

### 5-14 Treasurer's Report

RE Connie Badgley, Treasurer, opened in prayer and presented the 2019 Year-To-Date financial report. The reports were made available to the Presbytery.

#### 5-15 Community of Churches

TE Shawn Robinson, Clayton Community Church, Clayton, CA, updated the Presbytery on the history of his church, their mission, and the current joys and challenges they are experiencing as a community. He also thanked the Presbytery for their support over the years. Moderator Perkins presented a POPS carabineer to TE Robinson to affirm his church's connection to the POPS community and TE Mark Wollan prayed for TE Robinson and the church.

### 5-16 Ministerial Committee Report

TE David Abdo, Chair, opened in prayer for the churches in the Presbytery that are involved in search processes. He then introduced Jason Yum to the Presbytery, who was transferring from the EPC Presbytery of the Pacific Northwest as a Minister Without Call. Jason and his wife have relocated to the Bay Area and he desires to participate as a member of the Presbytery of the Pacific Southwest. He was previously a member of the Presbytery of the Pacific, of which POPS was a part.

Jason's examination began with a sermon delivered earlier in the meeting (see 5-5) on Jeremiah 31:31-34, which was a passage assigned by the Ministerial Committee. The Presbytery examined him on his views on theology, sacraments, the English Bible, the Book of Order, history of the Church, the Reformed tradition, his faith in Christ, his calling to the ministry, his progress in spiritual growth and the nature of the office of Teaching Elder. Jason had no exceptions to the Westminster Standards.

#### Motion was sustained to end the examination.

Candidate Yum was dismissed from the room.

TE Abdo read a letter from TE Troy Wilson in support of Jason. TE Nancy Duff also spoke on Jason's behalf. She explained the reasoning for Jason's transfer to the Presbytery as a Minister Without Call and the consideration provided by Stated Clerk Eshoff, RE Ron Bengelink, Stated Clerk of the Presbytery of the Pacific Northwest, and EPC Assistant Stated Clerk Jerry Jamurri.

Motion was sustained to receive Jason Yum into full membership in the EPC Presbytery of the Pacific Southwest as a Minister Without Call, pending his dismissal from the Presbytery of the Pacific Northwest.

Jason was invited back into the room and was greeted with a standing ovation. Moderator Perkins prayed for Jason.

# 5-17 Change of Status – TE Kirk Bottomly

TE Kirk Bottomly desires to continue to be active in the Presbytery and has requested a change in his status from Associate—Retired to Active—Retired. He recently assisted in leading the Presbytery Discovery Workshop.

Motion was sustained to approve the change in status of TE Kirk Bottomly from Associate-Retired to Active-Retired.

# 5-18 Generosity Resources Report

RE Bobby Cobbs introduced a video produced by EPC Generosity Resources and shared the opportunities available for individuals and churches to participate in the Generosity Resources ministry.

# 5-19 Meeting Recess and Prayer

Moderator Perkins thanked the Presbytery for their attention and prayed for dinner. The meeting recessed at 5:10 pm.

A dinner was prepared and served by the First Presbyterian Church, Bakersfield, CA.

# **Worship Service**

Rev. Jeff Chandler, Pastor of First Presbyterian Church, Bakersfield, CA led a worship service for the Presbytery and presented the evening message. The service also include the celebration of Communion and an offering for the *POPS Educational Assistance Fund*.

# FRIDAY, MAY 17, 2019

# 5-20 Call to Order and Opening Prayer

TE Rob Perkins, Moderator, reconvened the meeting and opened in prayer.

#### 5-21 Declaration of a Quorum

Stated Clerk Eshoff declared that a quorum was present.

#### 5-22 Introduction of Additional Guests

Moderator Perkins asked for guests and new commissioners that weren't present on Friday to stand and be recognized.

# 5-23 Appreciations to the Host Church

Moderator Perkins expressed deep appreciation to the host church, First Presbyterian Church, Bakersfield, CA, TE Jeff Chandler, Operations Manager John Bilotta and all the volunteers for their involvement and support. He praised the generosity of the Session and congregation for making it possible to host the meeting of the Presbytery and thanked the volunteers for doing a wonderful job welcoming the Presbytery.

#### 5-24 Morning Worship

Marsha Skidmore from First Presbyterian Church, Bakersfield, CA led the Presbytery in worship. TE Dave Huusko, Hope Presbyterian Church, Folsom, CA shared a sermon on Luke 24:28-32. Moderator Perkins then asked the Presbytery to pray around their tables with a focus on Deuteronomy 6 and Psalm 78.

#### 5-25 Pacific Women's Link

RE Rebecca Duvall opened in prayer and shared about the opportunity for women to gather together before each Presbytery meeting and to take advantage of the resources available from the Pacific Women's Link. She also reported on the EPC Women's Resource Council and its goal to connect women across the denomination.

# 5-28 Resource Presentation – "Growing Young"

Brad Griffin, Director of the Fuller Youth Institute and co-author of "Growing Young," and several other books, gave an in-depth 2-hour presentation on the future of the Church and how our churches can thrive and instill hope. He shared data from his research and focused on how churches can connect with those in younger generations. Moderator Perkins prayed for Brad and the ministry of the Fuller Youth Institute.

#### 5-29 Clerk of Session Training

During the lunch hour, Stated Clerk Eshoff and RE Jim Conners led a training for Clerks of Session from churches in the Presbytery.

# 5-30 Mission Committee Report

TE Dave Fenska, Interim Chair, opened in prayer and reported on the process to identify a people group for the Presbytery to sponsor as a part of the EPC Engage 2025 Project. He introduced TE George Carey, TE Greg Livingstone and EPC missionaries Rob and Iris Antonucci. The group presented information about the Pashtun people group and the opportunity to minister to them both locally and in Afghanistan.

# Motion was sustained to adopt the Pashtuns as an unreached people group for an Engage 2025 mission project.

Rob Antonucci prayed a prayer of thanks and blessing for the ministry to the Pashtuns. TE Greg Haroutunian prayed for the POPS Home Team and for the Antonucci's.

#### 5-31 Ministry of Prayer

RE Sydney Bollanger updated the Presbytery and offered prayer for TE Marsha Roth, who is dealing with serious health issues.

# 5-32 Ministerial Committee Report (continued)

#### **Retirement of TE Paul Bergquam**

Paul was born in San Mateo, CA and grew up in Escondido, CA. After moving with his family to Bellevue, WA, he attended the University of Washington, where he surrendered his life to Jesus Christ and became involved in missions. His mission travels included Europe, Africa, Central Asia and most recently, Thailand. He currently serves on the board of Frontier Laborers for Christ, a ministry in Southeast Asia and Paul plans to teach and disciple Muslim-background believers in France and Tunisia. Paul graduated from Dallas Theological Seminary (MS Biblical Studies) and received a Ph.D. in Old Testament Theology from Trinity Seminary in Newburgh, IN. He has served as Pastor of Sanger Community Church in Sanger, CA since 2011 after a brief stint there as Temporary Preaching Pastor, with previous calls to Trinity Presbyterian Church, Clovis, CA and Oakview Baptist Church, Auberry, CA, as well as mission calls in France and West Africa with SIM and CURE. The Presbytery honored him for his dedicated leadership in the Body of Christ.

RE John Walker shared about the impact of Paul's ministry to Sanger Community Church and Terry Lewis, a member of the church, prayed for Paul. Paul intends to remain an active participant in the Presbytery.

Motion was sustained to approve the change in status of TE Paul Bergquam from Active Member to Active–Retired, with grateful appreciation for his service to Sanger Community Church, the Presbytery and the Body of Christ.
