#### 19-3 Welcome

TE Brandon Morrow, Pastor of Moraga Valley Presbyterian Church, welcomed the Presbytery and shared a brief update on the ministry of the church.

## 19-4 Introduction of New Commissioners and Guests

Moderator Roberts welcomed all commissioners and guests. Personal introductions were given to those who were attending a Presbytery of the Pacific Southwest meeting for the first time.

#### 19-4 Installation of New Moderator

Moderator Roberts and Stated Clerk Eshoff, members of the POPS Presbytery Council, presented RE Brian Wyatt from Fremont Presbyterian Church, Sacramento, CA, Moderator-Elect with the chain of carabiners representing the 32 connected churches in the Presbytery, and the moderator's gavel, both of which he would be a trustee during his term as Moderator of the Presbytery. TE Roberts gave a charge to the new Moderator and Moderator Wyatt then shared his hopes for the Presbytery. Past Moderator RE Jim Conners prayed for RE Wyatt in his new role. Past Moderator Conners shared his thanks to God and the Presbytery, and TE Abdo prayed a prayer of thanks for him.

## 19-5 Recognition of Past Moderator

New Moderator Wyatt thanked TE Roberts for her service and invited her to share her thoughts regarding her term as Moderator. Stated Clerk Eshoff presented TE Roberts with a recognition gift and prayed a prayer of thanks for her as she transitions to the role of Past Moderator.

#### 19-6 Worship

Moderator Wyatt led the Presbytery in a Call to Worship from Psalm 150. The Worship Team from MVPC led the Presbytery in musical worship. The sermon on 1 Kings 19:1-8 was given by TE Dave Ricketts Associate Pastor at MVPC.

## 19-7 Moderator's Time of Prayer

Moderator Wyatt then led a time of prayer focused on Jude 1 Peter 5:1-11. Members, commissioners and guests prayed the scripture in small groups.

## 19-8 Stated Clerk's Report

Stated Clerk Eshoff reviewed the protocol for participation and voting for the meeting. He also noted attendance expectations, the voting guidelines for the Presbytery, and those Teaching Elders that were absent without excuse at the previous Presbytery meeting held on October 13-14, 2023. He presented the 2024 Parity List and the job description for the new POPS Chaplain position. He encouraged the Presbytery churches to turn in their Annual Church Reports and asked the TE members of the Presbytery to respond quickly to the request for their TE Annual Reports. He noted the passing of TE member Dennis Tarr. TE Sam Knottnerus prayed for Dennis' wife Christine and their family.

### 19-9 Approval of the Docket

Stated Clerk Eshoff presented changes to the proposed docket and recommended the revised docket to the Presbytery for approval.

Motion was sustained to adopt the docket as modified.

#### 19-10 Session Minutes Review Committee

RE Janet Goodman, Chair of the Session Minutes Review Committee, opened in prayer, reported on the reviews from the October 2023 meeting, and updated the Presbytery on how to improve the effectiveness of Session Minutes. She also communicated the need for additional members of her standing committee for the current year.

### 19-11 Introduction of Breakout Session Topics and Leaders

Presenters for each of the following Breakout Sessions gave a brief overview of the content of their presentations. Attendees were asked to choose 2 of the 5 offerings:

I Need to Train our New Officers? Resources to Assist You – Stated Clerk, Mark Eshoff

The Presbytery was then dismissed to attend one of the Breakout Sessions.

## 19-12 Lunch Meetings

Lunch was served by the MVPC volunteers. The Session Minutes Review Team met for an orientation during lunch and the Missions Team met and gave a presentation on the Pashtun Ministry in the Presbytery.

#### 19-13 Church Planting Update

TE Shawn Robinson, POPS Church Planting Coordinator, opened in prayer and gave an update on the progress of church planting in the four regions of the Presbytery. He noted that the Church Planting 101 E-book has been published by the GA Church Planting Committee. He then invited TE Troy Wilson and his wife, Caroline, to give an update on the ministry of The Table, our previous mission church and now local church in San Francisco, CA. They shared the personal challenges they have faced this past year. TE Robinson prayed for them.

## 19-14 Church Health Update

TE Mike Griffin, POPS Church Health Coordinator, opened in prayer and gave an update on the various churches taking advantage of the Church Health resources provided by the Presbytery, which included Church Health, Evangelism and Transitional Pastor Training. He noted that workshops would also be presented at the upcoming GA in June. TE Griffin closed in prayer.

## 19-15 Treasurer's Report

RE Connie Badgley, Treasurer opened in prayer and gave the financial report, which included the year-end POPS Financials, Askings Reports and Year-end Financial Review (attached). She noted that the calculation of Askings in 2024 has changed from Per Member to Percentage of Income for both the Presbytery and the denomination. A calculation of the POI amount for each church (attached) was included in the meeting docket. She highlighted the various Presbytery designated funds, including the POPS Educational Assistance Fund, which was the recipient of the offering at the worship service later in the evening. RE Badgley closed in prayer.

#### 19-16 Retirement Recognition of Connie Badgley, Outgoing Treasurer

Stated Clerk Eshoff led a time of recognition for Connie and thanked her for her continued service as Treasurer for both the Presbytery of the Pacific Southwest and the Presbytery of the Pacific Northwest for 12 years. After she shared briefly to the Presbytery, Stated Clerk Eshoff presented a gift to Connie, and TE Nancy Duff offered prayer for her in the season of her life and service.

## 19-17 Presentation by Patrick Coelho, GA Chief Financial Officer

Pat Coelho, Chief Financial Officer for the General Assembly updated the Presbytery on the current activities of the GA, including EPC's Four Gospel Priorities.

# **19-18 Ministry Update – Community Presbyterian Church, Danville** TE Cathy Burkholder TE Cathy Burkholder provided an update on ministry of Community Presbyterian Church. She shared a recently produced video and noted the impact, joys, challenges, and prayer

needs of the church. RE Christine Deane prayer for Cathy and the church.

## 19-19 Care of Candidates Report

TE Matt Young, Chair

#### **Examination of Mao Shimizu**

Mao was ready to come under the care of this Presbytery. He was currently under care of the Session of Wintersburg Presbyterian Church, Santa Ana, CA. The Session had recommended him to the Presbytery as a Candidate Under Care and he had met with the POPS Care of Candidates Committee.

The Candidate briefly shared his spiritual journey, his sense of call and why he has chosen the EPC. The Presbytery then examined him on the following:

- Christian experience and growth
- The motive for seeking ordination in the EPC
- The candidate's call to the Ministry

#### Motion was sustained to arrest the examination.

Rev. Ted Esaki, Stated Supply Pastor at Wintersburg Presbyterian Church, spoke on behalf of Mao.

## Motion was sustained to approve Mao Shimizu to come under care of the EPC Presbytery of the Pacific Southwest and approve TE Scott Larson as advisor to Candidate Shimizu

Moderator Wyatt then asked Candidate Shimizu the Constitutional Questions to which the candidate replied affirmatively. TE Jason Yum prayed for Candidate Shimizu and TE Scott Larson gave him a charge from 2 Timothy 4.

#### 19-20 Examination of Rick Dorr

Rick was considering a call at a church in our Presbytery but was not yet ordained and had not completed an MDiv. Degree. He had served as pastor of churches in several states and denominations for over 30 years. Per the Book of Order, Rick must enter candidacy status in order to pursue the Candidate's Educational Equivalency Program (CEEP) which, once completed, would then enable him to take the EPC ordination exams and be examined for ordination in the EPC. TE Young explained the CEEP process and the reason that Rev. Dorr needed to be received as a candidate in order to enter the process and receive a recommendation from the GA Ministerial Vocation Committee. The candidate had met with the POPS Care of Candidates committee and was recommended for approval.

Rev. Dorr briefly shared his spiritual journey, his sense of call and why he had chosen the EPC. The Presbytery then examined him on his Christian experience and growth, his motive for seeking ordination in the EPC, and his candidate's call to the Ministry

#### Motion was sustained to arrest the examination.

TE David Abdo spoke on behalf of Rev. Dorr and further explained why he and the Ministerial Committee were supportive of Rick and the motion.

Motion was sustained to approve Rick Dorr to come under care of the EPC Presbytery of the Pacific Southwest and approve TE Guy Boyer as advisor to Candidate Dorr.

Motion was sustained to refer candidate Rick Dorr to the GA Ministerial Vocation Committee for the Candidate's Educational Equivalency Program for the purpose of receiving a recommendation from them regarding requirements for his ordination in the EPC.

TE Young prayed for Rick and the process that he was entering.

## 19-21 Descending Overtures from the 43<sup>rd</sup> General Assembly

Stated Clerk Eshoff presented the two overtures that were approved by the General Assembly in June 2023 to be sent to the EPC presbyteries for their approval.

#### **Descending Overture 23-A**

This amendment clarifies the authority of the Session alone over all financial matters of the Local Church and eliminates outdated, ambiguous, or confusing references to financial responsibility of the Board of Deacons.

Motion was sustained by a vote of 52-YES and 0-NO and 0-ABSTAIN to approve Descending Overture 23-A: That the Book of Government 17-5 be deleted, with the following sections renumbered, and the Book of Government 6-8D and 18-3H be amended.

#### **Descending Overture 23-B**

"Church Discipline is not designed to deal with criminal acts apart from the authority of the civil magistrates." (Westminster Chapter 23-4). This preface to our practice of Ecclesiastical Discipline does not replace our responsibility to obey civil authorities and to protect the victims of abuse. This amendment clarifies that responsibility.

Motion was sustained by a vote of 56-YES and 0-NO and 0-ABSTAIN to approve Descending Overture 23-B: That the Book of Discipline 1-1 be amended.

## 19-22 Retirement Recognition – TE Dave Fenska

Dave has been a part of the EPC since 1985. He served as either a pastor or transitional pastor for 30 years in Southern California and Arizona before stepping into service with EPC World Outreach. Dave and Mindy have worked side by side in World Outreach for the past 8½ years as Missions Mobilizers and Refugee Care Coaches for the Western U.S. Dave's undergraduate degree is from Biola University, and his M.Div. is from Bethel Seminary. He also earned an M.A. in Christian Education from Talbot Seminary. Dave and Mindy make their home in San Diego. They enjoy time spent with their family, especially their seven grandchildren.

Moderator Wyatt invited TE Dave Fenska and his wife, Mindy, onto the platform and introduced the ceremony. Stated Clerk Eshoff shared a summary of Dave's ministry and his service to the Presbytery. Shawn Stewart from GA World Outreach shared the impact of Dave's ministry. Dave then reflected on the joys of his ministry as well.

Motion was sustained to approve the change of status of TE Dave Fenska from Teaching Elder Administrator to Active-Retired, effective December 31, 2023, with great appreciation for his service to the church, to the Presbytery, and to the denomination.

Dave was presented with a recognition gift and members of the various churches where Dave had served were invited forward to lay hands on him. TE Sam Knottnerus prayed for Dave and Mindy in this new season.

#### 19-23 Meeting Recess and Dinner

The meeting was recessed until the following morning at 9:00 am. Dinner was served by the MVPC volunteers.

#### 19-24 Presbytery Worship Service

The POPS Worship Service was led by TE Brandon Morrow and the staff and leaders from Moraga Valley Presbyterian Church. Communion was served, and an offering was received for the POPS Education Assistance Fund.

## 19-25 Call to Order and Opening Prayer

Following a breakfast served by MVPC volunteers, RE Brian Wyatt, Moderator called the meeting to order at 9:05 am on January 27, 2024 and opened in prayer.

### 19-26 Appreciation to the Volunteers and Staff of the Host Church

Moderator Roberts expressed deep appreciation to MVPC, their pastors and staff, and the volunteers that served the Presbytery in hosting the meeting.

#### 19-27 Worship

Moderator Wyatt led the Presbytery in a Call to Worship from \_\_\_\_\_. The Worship Team from MVPC then led the Presbytery in musical worship. The sermon was given by TE Joe Tolin, Candidate for Pastor at Kingman Presbyterian Church, Kingman, AZ. He preached on Titus 3:3-7, a passage assigned to him by the Ministerial Committee.

#### 19-28 Moderator's Time of Prayer

Moderator Wyatt then led a time of prayer focused on Isaiah 40. Members, commissioners, and guests prayed the scripture in groups.

#### 19-29 Ministerial Committee Report

TE David Abdo, Chair of the Ministerial Committee, opened in prayer and welcomed TE Joe Tolin back to the platform.

#### **Examination of TE Joe Tolin**

Joe Tolin had been called as Pastor by the congregation of Kingman Presbyterian Church, Kingman, AZ. He had signed his Ministerial Obligation Form and Ethical Affirmation Form. He had been examined by the members of the Ministerial Committee and his current Terms of Call had been reviewed and approved by the Committee. He was seeking to transfer from the EPC Presbytery of Florida and the Caribbean and was recommended to the Presbytery for approval.

Joe's examination began with a sermon on a passage assigned by the Ministerial Committee. The Presbytery examined him on his views of theology and sacraments, his faith in Christ, his calling to the ministry and the nature of the office of a minister of the

Word, polity, the Reformed tradition, the Bible, and his spiritual journey. Joe had no exceptions to the Westminster Standards.

TE Tolin was excused from the room during the discussion. TE Dave Fenska from Kingman Presbyterian Church spoke in support of TE Tolin.

Motion was sustained to approve the examination of TE Joe Tolin and receive him into full membership in the EPC Presbytery of the Pacific Southwest.

Motion was sustained to approve the Administrative Commission of TE's Dave Fenska and Greg Alderman and RE's Sharon Spencer, Chris Beard, and Joan Johns from Kingman Presbyterian Church and Stephen Morris from Covenant Presbyterian Church, Orange, CA to install TE Joe Tolin as Pastor of Kingman Presbyterian Church on February 25, 2024 at 10:30 am.

TE Tolin was invited back into the room and received a standing ovation. Members of the Kingman Church were invited forward to lay on hands and TE Dave Fenska prayed for Joe and the church in Joe's new call.

#### 19-30 Change in Status – TE David Burke

The congregation of Fremont Presbyterian Church had approved the request of TE David Burke to dissolve his relationship with the church. TE Burke was invited forward to share about his new call.

Motion was sustained to approve the dissolution of the relationship between TE David Burke and Fremont Presbyterian Church, and to change his status to Without Call effective January 14, 2024.
