## 22-3 Welcome

TE Bryan Yeo, Pastor of Community Presbyterian Church, welcomed the Presbytery and shared a brief update on the ministry of the church.

#### 22-4 Introduction of New Commissioners and Guests

Moderator Wyatt welcomed all commissioners and guests. Personal introductions were given to commissioners who were attending a Presbytery of the Pacific Southwest meeting for the first time.

#### 22-5 Worship

Moderator Wyatt led the Presbytery in a Call to Worship from Hebrews 4:14-16. The Worship Team from CCC led the Presbytery in musical worship. The sermon on Hebrews 1:1-4 was given by Ryan Balbi, candidate for Pastor at Christ Community Church, Carmichael, CA.

## 22-6 Moderator's Time of Prayer

Moderator Wyatt then led a time of prayer focused on 1 Corinthians 16:13-14. Members, commissioners, and guests prayed the scripture in small groups.

#### 22-7 Stated Clerk's Report

Stated Clerk Eshoff reviewed the protocol for participation and voting for the meeting. He also noted attendance expectations, the voting guidelines for the Presbytery, and those Teaching Elders that were absent without excuse at the previous Presbytery Meeting held October 11-12. 2024. He reminded the Presbytery about the need for churches to host future meetings, the importance of returning Church Annual Reports and Teaching Elder Annual Reports on a timely basis, the upcoming Discovery Workshop at Cornerstone Woodlake Church, the upcoming EPC Next Gen Summit, and noted the resources available from the General Assembly office, including the update on EPC Gospel Priorities that was included in the Meeting Packet.

#### 22-8 Approval of the Docket

Stated Clerk Eshoff presented changes to the proposed docket and recommended the revised docket to the Presbytery for approval.

#### Motion was sustained to adopt the docket as modified.

#### 22-9 2025 Parity List

Stated Clerk Eshoff presented the proposed 2025 Parity List to the Presbytery which was designed to ensure a ratio of 2 Ruling Elder to 1 Teaching elder representation at Presbytery meetings.

## 22-10 Ministerial Committee Report

TE David Abdo opened in prayer and introduced Ryan Balbi, candidate for Pastor at Christ Community Church, Carmichael, CA.

#### Examination of Ryan Balbi

Ryan had been called as Pastor by the congregation of Christ Community Church, Carmichael, CA. He had signed his Ministerial Obligation Form and Ethical Affirmation Form. He was examined by the members of the Ministerial Committee and his current Terms of Call were reviewed and approved by the Committee. He was recommended to the Presbytery for approval.

Ryan's examination began with a sermon on a passage assigned by the Ministerial Committee. The Presbytery examined him on his knowledge of theology and sacraments, his faith in Christ, his calling to the ministry, the nature of the office of a minister of the Word, polity, the Reformed tradition, the Bible, and his spiritual journey. Ryan had no exceptions to the Westminster Standards.

#### Motion was sustained to arrest the examination.

Ryan and his family were invited to leave the room during the Presbytery discussion. RE's Alexis Johnson and TE Dustin DeVriend from Christ Community Church spoke in support of Ryan.

Motion was sustained to approve the examination of Ryan Balbi and receive him into full membership in the EPC Presbytery of the Pacific Southwest.

## Motion was sustained by a vote of 62-Yes and 0-No to approve Descending Overture 24-A: That the Book of Government 10-7 and 9-5 be amended.

## 22-22 Ministry Update – New Life Community Church, Covelo CA

RE Linda Marshall provided an update on New Life Community Church, Covelo, CA, including the completion of their new sanctuary and the joys, challenges and prayer requests for the church. Stated Clerk Eshoff prayed for her and the church.

The meeting was recessed until the following morning at 9:00 am. Dinner was served by the CCC volunteers.

## 22-25 Presbytery Worship Service

The POPS Worship Service was led by TE's Bryan Yeo, Jeff Hooker and Rachel Dorsey, all who preached on the attributes of God. Communion was served and an offering was received for the POPS Church Planting Fund.

## 22-26 Call to Order and Opening Prayer

Following a breakfast served by CCC volunteers, Moderator Wyatt called the meeting back to order at 9:00 am on Saturday, January 26, 2025, and opened in prayer.

#### 22-27 Appreciation to the Volunteers and Staff of the Host Church

Moderator Wyatt expressed deep appreciation to Centerpoint Community Church, their pastors and staff, and the volunteers that served the Presbytery in hosting the meeting. The volunteers were given a standing ovation.

#### 22-28 Worship
